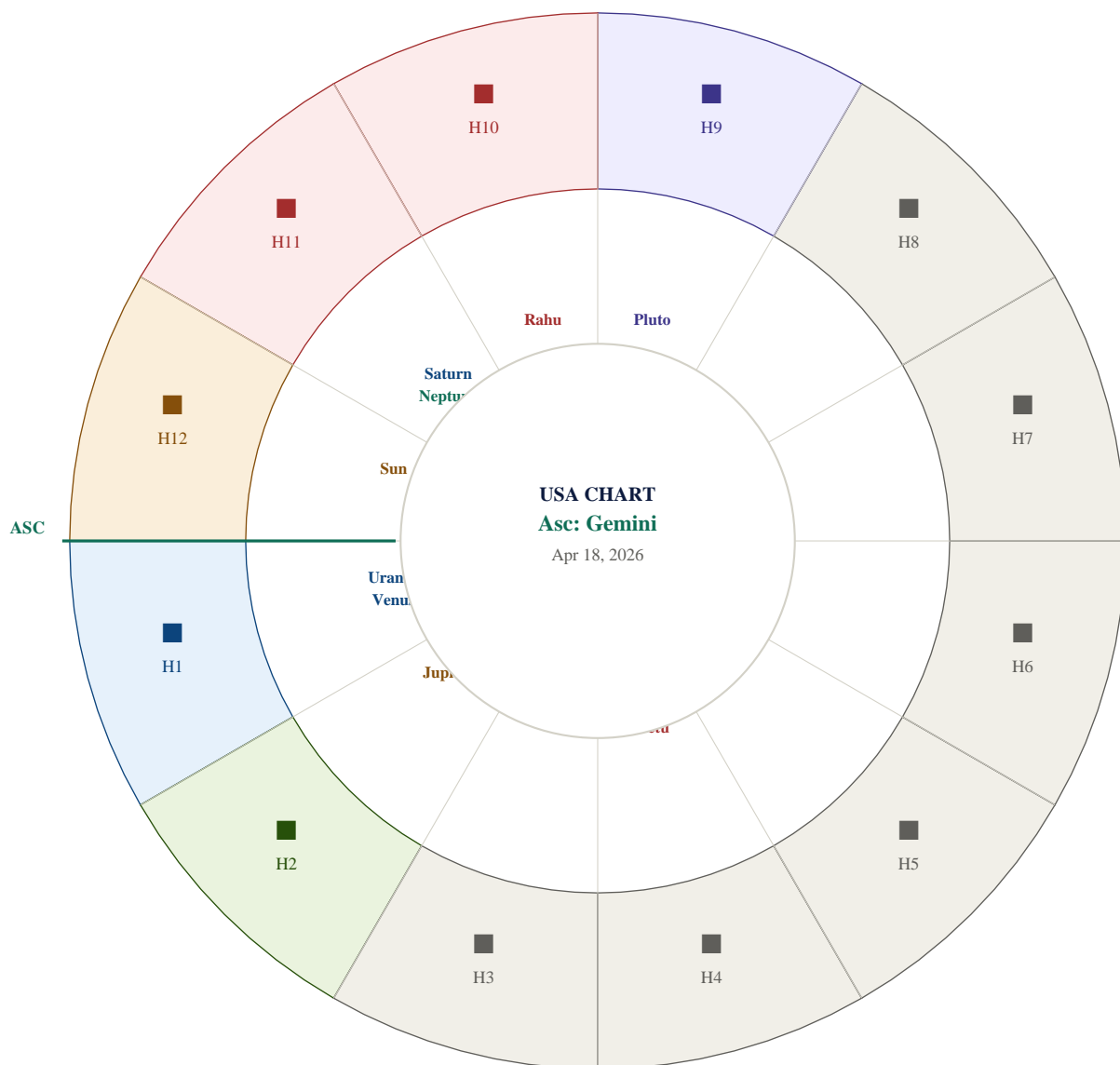

III. Current Planetary Positions & Their National Significance

A. 11th House — Aries (Congress & Legislature): The Crisis Stellium

This multi-planet stellium is the most explosive configuration in the USA's chart. The once-in-36-years Saturn-Neptune conjunction perfected on February 20, 2026 at 0° Aries.

B. 10th House — Pisces (The Presidency): Rahu's Iron Grip

Rahu currently occupies Pisces — the USA's 10th House governing the President and the executive branch. Prof. Palaniappan's text describes Rahu as governing "political plots, banishment, accidents, foreigner's trouble, litigation, gambling." Rahu in the 10th House of the Presidency signifies a leader deeply entangled in foreign affairs, legal battles, and power through unconventional means. Market Key Dates to Watch
